This attachment shall be considered a continuation of the call for bids, and by reference made a part thereof.

Dawson Community College reserves the right to reject any or all bids, to waive irregularities, or to accept any bid they deem to be in the best interest of the College.

BASIS OF THE AWARD shall be dependent on the most responsible bid submitted. Consideration will be given to purchase price, delivery date, equipment service guarantees, parts and service availability, parts and service facilities location, analyses and comparison of equipment specification details, and past experience of Dawson Community College with similar or related equipment.

No bid will be accepted without a minimum of a three (3) year or thirty-six thousand (36,000) mile manufacturer warranty.

**Vehicle bid must be a new vehicle with less than 5,000 miles.**

Pursuant to the call for bids, the following minimum requirement shall be met:

- A. Vehicle shall meet Montana Department of Transportation requirements and specifications on the date of the bid opening.
- B. Delivery shall be F.O.B. Dawson Community College, Glendive, Montana.
- C. The bid shall include all operating, service, parts, and technical repair manuals.
- D. Bidders must specify delivery date.
- E. Vehicle shall be a 2018 or newer advertised model, with all the latest features offered as standard whether or not called for in the specifications; except where this specification requires a substitution in lieu of the manufacturer's standard equipment.
- F. Bids will not be considered that do not include a copy of the manufacturer's literature/specification material or include an incomplete specification portion of the bid sheets.

G. Vehicle shall come with all-wheel or four-wheel drive.

Please indicate in the following list if the vehicle offered can meet the desired configuration. Any “no” should be clarified below if the bidder desires support for an alternate specification. Failure to do so may result in non-acceptance of the bid.

## **VEHICLE WARRANTY & AVAILABILITY GUARANTEE**

The intent of this clause is to guarantee the cost of repairs and downtime to Dawson Community College. Therefore, all bidders shall include with their bid:

Vehicle bid must have a full manufacturer's warranty for a minimum of three (3) year or thirty-six thousand (36,000) miles, whichever occurs first from the date of delivery. The only exclusions shall be wear items that experience normal wear in the ordinary course of use such as tires, glass, etc.

Dawson Community College will make the vehicle available for repairs and inspections as requested by the dealer.
